- RBANA01 Membership Policy & Procedures Article 8 *“Dues for all classes of dues paying annual membership shall be due and paid by January 1 of the calendar year. Dues received after March 31, shall be assessed a \$5.00 late fee in the currency of their country of residence. For those members not residing in Canada or the US, late fees, can be paid in Canadian dollars.”*
